The purpose of this email is to notify you that as of July 28, 2017, Enterprise Engineering, Inc. has completed the boundary survey of the subject parcel, legally described as Tract 3, Potter Creek Subdivision, per Plat No. 71-202. While conducting this boundary survey, the two southern property corners were recovered and the two northern corners were determined to be unmonumented/missing. We recovered monumentation of record on adjacent parcels which were used to compute the location of and install the monuments on the two northern property corners. Our measurements of recovered and set monumentation agree record information with little to no discrepancy. Record of Monument forms for the northern corners, set this survey, are in the process of being recorded with the Alaska Recorder's Office and we will provide you with copies of these documents once recorded.


