Hi Matt,

I worked with Stacy in preparing the Plot Plan fee proposal. I have experience with MOA Building & Land Use permitting and can address your questions.

Attached for your reference is a MOA Checklist outlining requirements for a Land Use permit. The Plot Plan EEI will prepare addresses item "C" of the checklist.

For our use in preparing the Plot Plan, you would provide us a plan showing layout/dimensions of building, decks, overhangs, etc, as would be shown on a floor plan (required by item "D" of the checklist). You would also delineate the planned driveway location, that would include switchbacks, parking area, etc. The MOA will want to see this, to see that maximum slopes aren't exceeded.

Our proposal did not include submitting to the MOA, or meeting with the MOA during permitting. We had an exclusion about "no revisions", which is regarding a major change to building configuration or location after certifying the plan. A minor revision necessary to address a MOA review comment could probably be accommodated for the lump sum fee. Meeting with the MOA, trying to get it "pushed through", is better handled by the owner (or a permit expediter). The time required for that is quite unpredictable.
